New Timber Stack Play Structure Coming to Nadaka Park This Spring

After many years providing endless hours of physical activity and inspiring young imaginations the original log house play structure at Nadaka Park's nature-based play area is being replaced.

The new play structure is being built with durable/pest resistant timber stack logs made from sustainable black locust wood. Black locust is a very hard and strong wood, competing with hickory as the strongest and stiffest

domestic timber: but with more stability and rot resistance.

The original play structure, built in 2014, began to show signs of rot after years of exposure

to the elements. It was construct ed using pealed logs made

from approximately 12 Douglas fir trees removed from within the park due to laminated root rot; a fungal disease passed from tree to tree through direct root contact causing decayed roots to separate at the annual rings like pages in a book, weakening the tree's ability to stand.

Replacement of the old play structure began in January 2023. The new structure is expected to be completed early Spring 2023. For more information contact Tina Osterink

(compared to 4100 for the old), so they should be a little brighter, and use 15W less power. The perception that they are dimmer is probably due to the different lighting pattern, possibly diffusing the light to a larger area but looking dimmer overall (while providing more lumens)".

> The city released this statement: "The City of Gresham is in the process of replacing most of the LED streetlights in neighborhoods and along arterial roads with newer, brighter, and more efficient units that spread their light more evenly.

Wilkes East Land-Use Update

The Wilkes East Neighborhood Association board regularly receives land use plans from the City of Gresham to notify us of land use projects within or proximity to the Wilkes East neighborhood boundaries. We are recapping some of the projects from the summer and fall WENA Newsletters as well as some projects in the Rockwood and North Gresham neighborhoods.

Plan case PRE-22-00376

Application Date 5/31/2022

Location: 2777-2789 NE 181st Ave, Gresham Or 97230. The proposed Cyberwash car wash building will includes a 110-foot-long tunnel design, overall dimensions 127 feet long by 48 feet wide, total building gross square footage 5000 sq. ft.

UPDATE: As of this date, the Wilkes East Neighborhood Association has NOT received Early Neighborhood Notification meeting documentation as required.

Plan Case DR-22-00328 (Rockwood NA) Application Date 05/19/2022

Location: NE 165th and Burnside. The proposal is as follows: New 92-unit multi-family affordable apartment development consisting of one, two and three bedroom units.

City of Gresham Replaces LED **Streetlights**

Starting in 2014, the City of Gresham replaced 8000

streetlights with more efficient LED lights. Gresham was one of the first cities in Oregon to completely switch over to LED lights. The City Gresham was recognized with the 2015 Sustainable Practices Award from the Oregon Chapter of the American Public Works Association.

At the end of 2022, workers began replacing the LED lights with a new generation of LED light. There was a perception that these new LED lights were dimmer than the old LED lights. So, we asked, are they dimmer?

Gresham's Transportation Division explains: "The new lights emit 4299 lumens

Update on WeShine Village at Parkrose Community United Church of Christ

The micro village that opened last fall on church property now has 10 occupants. You may have noticed the fence built around the village has been painted, too. In the near future they hope to have some artwork displayed on the outside of the fence. The residents are all doing well and are attending weekly check-in meetings. One person recently was able to get into permanent housing.

WeShine is in the process of getting permits and materials to begin construction of a community building, laundry room and bathroom in the village. The water line has been installed.

In the meantime, Parkrose Community UCC provides showers on Monday evening in partnership with the Union Gospel Mission. On Wednesdays from 11-2, we partner with Cultivate Initiatives who brings their mobile shower and laundry truck to the church. The

showers and laundry facilities are open to the micro village or anyone in the community that need the services. The church also continues to distribute healthy meals provided by Feed the Mass on Monday, Wednesday and Friday .

The first generation of LED streetlights, which were installed 2014-16, were found to have a design flaw, so the city has received the new lights under warranty.

URBAN FORESTRY IN GRESHAM

Urban Forestry is the study and management of a city's trees, on public and private property.

Gresham's Urban Forestry Subcommittee (UFS) began in 1990 as the Tree Preservation Council Advisory Committee. In 2008, the Tree Preservation Committee was renamed the Urban Forestry Subcommittee made up of City staff, tree professionals, and volunteers. Over the years, UFS has planted thousands of trees, tracked tree code violations, monitored the health of green spaces, identified areas of the city in need of tree canopy, and worked with neighborhoods in planting projects. UFS has also made major contributions to the online Tree Canopy Map, Right Tree in the Right Place, Significant Trees of Gresham, Street Tree List, Neighborhood Tree Plan, and the Tree Code. UFS has coordinated with organizations such as Arbor Day, and Friends of Trees, and helped make Gresham a "Tree City" for 14 years.

When the Urban Forestry Management Plan was published in 2011, it was at the height of enthusiasm for UFS. 50 participants including City Councilors, City staff, and UFS members worked on the development of this comprehensive 77-page document. Recently, however, UFS attendance has declined. At the UFS meeting in November 2022, attendees expressed a fear that UFS was going away. Tina Núñez-Osterink, UFS Staff Liaison and a major contributor to UFS was transferred to Parks and Recreation. Others were resigning due to a lack of cooperation from the City. Today, only three members remain.

At the January 23, 2023 UFS meeting, Eric Schmidt, Assistant City Manager, asked UFS not to meet for 2-3 months. Eric said that the City needed to get its house in order and figure out how to interact with UFS. UFS projects would be paused during that time.

Funding from federal programs and grants will be coming in and need to be used by June 2023. Eric said because UFS is "still on paper" and is "legally an active subcommittee," the City will be able to receive grant funding. Others in the City will handle that.

Eric said the City is aware of the subcommittee's frustration, and complaints have not gone unheard, but he did not say that the City would address concerns in the future. He gave no definite timeline for the resumption of meetings, [omit or] no plan for interim communication, nor did he give any commitments whatsoever, leaving the impression that the subcommittee was effectively shut down.

LAND-USE (Page 1)

No retail/commercial is proposed. Anticipated 4-story wood frame construction on conventional slab on grade foundation. Surface grade parking to be located to the North and East of proposed building. Site improvements and outdoor amenities to support development requirements including storm infiltration and two exterior courtyards.

<u>UPDATE:</u> Permit number <u>BLDMF-23-00541</u> applied for on 1/29/2023. Building review is scheduled for 2/22/2023. On-site existing homes have been now vacated and boarded up.

Plan Case PRE-21-00688 (Rockwood Neighborhood)
Applied date 12/09/2021

Habitat for Humanity development of the 1.41-acre site, comprising two lots, located on the south side of NE Glisan Street,





approximately 100 feet east of NE 176th Avenue (17616-17636 NE Glisan) directly south of Nadaka Nature Park. The proposal includes 7 buildings comprising a total of 20-units and 29 parking spaces in a surface parking lot. The elevations and site plan provided show a typical two-story structure with individual ground floor entries and small rear yards. A condominium review (subdivision) and parking reduction are also being proposed. NOTE: There has been no update from the city of Gresham regarding proposal.

Plan Case <u>DR-21-00616</u> Applied date 11/05/2021

Phase 1 of new construction of approximately 26,000 square foot pre-engineered metal building for Pape Machinery's new Ditch Witch facility located at 17217 NE Sandy Blvd. This is on the 11-acre property adjacent to the historical Zimmerman House. Due to site constraints all regulated trees are proposed to be removed. The Gresham Wetland report indicates no wetlands on this property. Phase 2 will include a second Pape Machinery facility. Update: DR 21-00616 has been completed, there has been no other update from the city of Gresham regarding proposal.

These plans and other public information can be viewed on Gresham Online Services portal where applicants can electronically submit Plan or Permit applications quickly and easily, and where interested parties searching for public records can search for project data or access the City's map service.


