Quarterly Meeting

6. Owner has lost 2 tenants (maybe more) because he's seen the loss of parking on street on NE Glisan.
7. NE 162nd & Halsey & Glisan is falling apart when will it be fixed?
8. Keep pedestrian crossing closer to Tri-Met stop and school
9. Prefer option that has most sidewalk.
10. Providing parking for you tenants is the cost of doing business.
11. Neither A or B need a third option place pedestrian crossing near junction of 172nd.
